The Paint Valley Alcohol, Drug Addiction and Mental Health (ADAMH) Board is responsible for ensuring a comprehensive array of mental health, addiction treatment and prevention options are available to all residents of our service district. The service district includes Fayette, Highland, Pickaway, Pike and Ross Counties. The Paint Valley ADAMH Board provides a safety net for services to those with little or no insurance. Providing Help and Offering Hope for 50 years

The Paint Valley Alcohol, Drug Addiction and Mental Health Services Board has been providing help to our community in some capacity for the past 50 years. Here is the history of how our Board was formed.

In 1967, Ohio enacted Amended Substitute House Bill (ASHB) 648, creating 53 Community Mental Health and Mental Retardation Boards, known as "648 Boards". The Paint Valley Board became the local managers of federal and state monies, earmarked for the planning and delivery of community-based mental health services for Fayette, Highland, Pickaway, Pike and Ross Counties.

In 1980, passage of ASSB 160 transferred responsibilities for mentally retarded clients to 169 Boards and we became the Paint Valley Community Mental Health Board.

In a move to integrate a system of care, both hospital and community-based, the Mental Health Act of 1988 gradually shifted inpatient funds to local Boards to provide



mental health and those recovery services essential for community living, including housing, case management and transportation.

Another change in board responsibilities quickly followed in 1989 with ASHB 317, the Alcohol and Drug Addiction Services Act, which established the Ohio Department of Alcohol and Drug Addiction Services and added the responsibility for alcohol and drug addiction prevention and treatment services to local Boards. Thus, "648 Boards" became "317 Boards". Because of this change, our Board became the Paint Valley Alcohol, Drug Addiction and Mental Health (ADAMH) Board.

News

The Board of Directors accepted the following grants at the January meeting:

- Local Employment Partnership Grant from ODMHAS to continue the "Empowering the Workplace" training in Fayette County.
- Prevention First Community Readiness Assessment Mini-Grant for the Highland County Drug Abuse Prevention Coalition.

In an effort to assist the homeless community in our Board area, the Board provided 125 stadium blankets to be distributed to the homeless during the Point in Time Count held on Tuesday January 24th in all five of our counties.

Our "Write in Red Essay Contest" winners have their \$500 prize deposited into their CollegeAdvantage Saving Plans. We are looking forward to next year's inspiring essays.
